Dear Members,

We are sure you must be safe and in good health. The outbreak of COVID-19 has disrupted normal life of everybody. All activities of the Club House have been discontinued since 22nd March, 2020 due to Lockdown.

As the restrictions are eased by the authorities, the Club House has begun to commence certain activities, like Catering, Banquet Hall Booking, Room Booking, Table Tennis and Badminton.

Due to lockdown, many esteemed members have missed the opportunity to apply for Membership for their Childrens:

- (a) Under Amnesty Scheme for their children, aged between 21 years & 60 years on payment of Entrance Fee of ₹ 10 Lakhs + 18% GST which can be paid in two equal six monthly installments.
- (b) Under Member's Friendly Scheme for Children with age from day one but below 18 years on payment of Entrance Fees of ₹ 5 Lakhs + GST which can be paid in four installments of six monthly.

Life Members or Ordinary Members who have completed 8 years membership are eligible to apply for Membership under these Schemes.

These members have periodically requested for extension of these Scheme. Your Managing Committee has considered this matter sympathetically and decided to extend above both the Schemes till 31st March'2021.

Members are requested to note and take advantage of the above Schemes for their eligible children before it is too late. These Schemes are extended to accommodate the members who have missed opportunity to apply due to prevailing situation.

Please note that the Ordinary Membership under Member's Son/Daughter Category for the Sons aged between 18 years & 21 years of Life or Ordinary Members with 8 years Memberships available, for which there is no limitation of date for applying.

The Entrance Fee for the same is  $\stackrel{?}{\sim} 5,00\,000/-+$  GST which can be paid either lum sum & in 4 six monthly installments.
